BY-LAW DIVIDING THE TERRITORY OF THE CITY
OF POINTE-CLAIRE IN MUNICIPAL ELECTORAL
DISTRICTS

In force on October 31, 2024

AT THE REGULAR MEETING OF THE COUNCIL OF THE CITY OF POINTE-CLAIRE HELD AT THE CITY HALL, 451 SAINT-JEAN BOULEVARD, POINTE-CLAIRE, QUEBEC ON TUESDAY JUNE 4, 2024, AT 7:00 P.M.

PRESENT: Councillors C. Homan, T. Stainforth and K. Thorstad-Cullen, as well as Councillors P. Bissonnette, C. Cousineau, B. Cowan, E. Stork and B. Tremblay forming quorum under the chairmanship of Mayor Tim Thomas.

AND RESOLVED:

WHEREAS a notice of motion of the present by-law has been given beforehand and the tabling of the draft by-law was done at the same meeting.

WHEREAS a draft by-law was previously adopted.

CONSEQUENTLY, THE MUNICIPAL COUNCIL DECREES AS FOLLOWS:

1. The territory of the City of Pointe-Claire, which had 25,530 electors in January 2024, is divided into eight (8) electoral districts named and bounded as follows:

Electoral District N° 1 – Cedar / Le Village

Starting from a point located at the intersection of the west municipal limit and De La Roche Avenue, from there : to the east, the western municipal limit in the northern limit of properties fronting on the north side of Windmill, the rear limit of properties fronting on the east side of Windmill and Amberley Avenues, its extension towards the south, Remembrance Highway (20), Saint-Jean Boulevard and its extension in a southerly direction into the St. Lawrence River, the southern municipal limit in the St. Lawrence River, the west municipal limit located west of De la Pointe-Claire Avenue then into the Lakeview Memorial Gardens cemetery, then south of Rondeau Street (Kirkland), and this, up to the starting point.

This district contains 2,944 electors, with a variation from the average of -8.00 % and has an area of 8.50 km².

Electoral District N° 2 – Lakeside

Starting from a point located at the intersection of Remembrance Highway (20) and the eastern municipal limit along Des Sources Boulevard, from there : towards the south, the eastern municipal limit on Des Sources Boulevard and its extension towards the south into the St. Lawrence River, the southern municipal limit in the St. Lawrence River, the extension towards the south of Saint-Jean Boulevard, the latter boulevard, Remembrance Highway (20), and this, up to the starting point.

This district contains 3,053 electors, with a variation from the average of -4.59 % and has an area of 10.77 km².

Electoral District N° 3 – Valois

Starting from a point located at the triple intersection of Reverchon and Newman Avenues and the eastern municipal limit, from there : towards the southeast, the eastern municipal limit successively on Newman Avenue, then on Des Sources Boulevard, then Deslauriers and Chanteclerc Avenues, then on Des Sources Boulevard again, Remembrance Highway (20), the extension towards the south of Broadview Avenue, the latter avenue, Saint-Louis Avenue, Reverchon Avenue, and this, up to the starting point.

This district contains 3,231 electors, with a variation from the average of +0.97 % and has an area of 1.86 km².

Electoral District N° 4 – Cedar Park Heights

Starting from a point located at the intersection of Hymus and Saint-Jean Boulevards, from there : towards the south, Saint-Jean Boulevard, Remembrance Highway (20), the southerly extension of the rear limits of the properties fronting on the east side of Amberley and Windmill Avenues, the latter limit, the western municipal limit running east around the properties on De Calais Street (Kirkland), then running west and north around the Lakeshore General Hospital property at 160 Stillview

Avenue, the southwesterly extension of Frobisher Avenue, the latter avenue and its northeasterly extension into Seignior Park, Whitley Avenue, Seignior Avenue, Alston Avenue, the limit separating the two properties at 139 and 141-1 Alston Avenue, the rear limits of the properties fronting on the northeast side of Alston Avenue, the northwest limit of Tony Proudfoot Park, Gendron Avenue, Paprican Avenue, Hymus Boulevard, and this, up to the starting point.

This district contains 3,652 electors, with a variation from the average of +14.12 % and has an area of 1.93 km².

Electoral District N° 5 – Lakeside Heights

Starting from a point located at the intersection of Broadview and Braebrook Avenues, from there : towards the southeast, Broadview Avenue and its southerly extension, Remembrance Highway (20), Saint-Jean Boulevard, Douglas-Shand Avenue, Maywood Avenue, Duke-of-Kent Avenue, Cavell Avenue, Dieppe Avenue, Hastings Avenue, the extension in a northeast direction of the southwest section of Braebrook Avenue into the limit separating the two properties at 97 and 99 Hastings Avenue, and then into the limit separating the two properties at 156 and 158 Spartan Crescent Avenue, the central section of Braebrook Avenue, the pedestrian path along the southeastern limit of the properties at 101 Arrowhead Crescent Avenue and 100 Winthrop Avenue, the northeastern section of Braebrook Avenue, and this, up to the starting point.

This district contains 2,742 electors, with a variation from the average of -14.31 % and has an area of 2.12 km².

Electoral District N° 6 – Seignior

Starting from a point located at the intersection of Saint-Jean and Brunswick Boulevards, from there : towards the southeast, Saint-Jean Boulevard, Hymus Boulevard, Paprican Avenue, Gendron Avenue, the northwest limit of Tony-Proudfoot Park, the rear limits of properties fronting on the northeast side of Alston Avenue, the limit separating the two properties at 139 and 141-1 Alston Avenue, Alston Avenue, Seignior Avenue, Whitley Avenue, the northeast extension of Frobisher Avenue into Seignior Park, Frobisher Avenue and its southwest extension into the northern limit of Lakeshore General Hospital at 160 Stillview Avenue, the west municipal limits (along Stillview Avenue) then northwest along Portway, Old Post Crescent, Roundtree Crescent, Hermitage, Carmel Crescent, Sunrise Crescent avenues, the rear limits of properties fronting on the northeast side of Sunrise Crescent Avenue, the northeast limit of the property at 351 Hermitage Avenue, the latter avenue, the pedestrian path along the northeast limit of the property at 365 Brunswick Boulevard, the latter boulevard, and this, up to the starting point.

This district contains 3,634 electors, with a variation from the average of +13.56 % and has an area of 2.12 km².

Electoral District N° 7 – Northview

Starting from a point located at the intersection of Labrosse Avenue and the northwest municipal limit on Tecumseh Avenue, from there : towards the southeast, the northwestern municipal limit on Tecumseh Avenue, the latter avenue and its extension in a southeast direction, Delmar Avenue, Hymus Boulevard, Winthrop Avenue, the pedestrian path along the southeast limit of the properties at 100 Winthrop Avenue and 101 Arrowhead Crescent Avenue, the central section of Braebrook Avenue, the extension in a southwest direction of the central section of Braebrook Avenue into the limit separating the two properties at 156 and 158 Spartan Crescent Avenue and then into the limit separating the two properties at 97 and 99 Hastings Avenue, the latter avenue, Dieppe Avenue, Cavell Avenue, Duke-of-Kent Avenue, Maywood Avenue, Douglas-Shand Avenue, Saint-Jean Boulevard, Brunswick Boulevard, the pedestrian path along the northeast limit of the property at 365

Brunswick Boulevard, Hermitage Avenue, the northeast limit of the property at 351 Hermitage Avenue, the rear limits of properties fronting the northeast side of Sunrise Crescent Avenue, the northwest municipal limit along Labrosse Avenue and then on Tecumseh Avenue, and this, up to the starting point.

This district contains 3,250 electors, with a variation from the average of +1.56 % and has an area of 3.64 km².

Electoral District N° 8 – Oneida

Starting from a point located at the intersection of the northwest municipal limits (on the southeast right-of-way of Brunswick Boulevard) and northeast (on Des Sources Boulevard), from there : in a southeasterly direction, the northeast municipal limit on Des Sources Boulevard, then using various sections of Montée Saint-Rémi, Reverchon Avenue, Saint-Louis Avenue, Broadview Avenue, Braebrook Avenue, Winthrop Avenue, Hymus Boulevard, Delmar Avenue and its extension in a northwest direction, Tecumseh Avenue, the northwesterly municipal limit along Oneida Avenue and Brunswick Boulevard, and this, up to the starting point.

This district contains 3,095 electors with a variation from the average of -3.28 % and has an area of 3.64 km².

2. The districts described hereabove, numbered and named, are outlined in the plan attached hereto as Appendix "A" forming an integral part of the present by-law.
3. In the present by-law, unless otherwise indicated, when one of the limits of a district is a highway, road, street, avenue or boulevard, said limit is located in the middle of such a highway, road, street, avenue or boulevard.
4. The present by-law replaces and repeals By-law PC-2919 dividing the territory of the City of Pointe-Claire in municipal electoral districts.
5. The present by-law shall come into force according to the law, under the restrictions of the dispositions of the Act respecting Elections and Referendums in municipalities (CQLR c E-22).
